## 1. Authorization

- (a) On April 30, 2013, Town Council passed a motion to provide written notice of its proposed annexation to Section 116 of the *Municipal Government Act* (the "Original Notice").
- (b) On February 11, 2014, Town Council passed a motion to proceed with a formal application to the Municipal Government Board to annex lands as set out in Section 2 of this Notice.

## 2. Amended Description of Land Proposed to be Annexed to the Town of Beaumont

- (a) Township 51, Range 24, West of the 4<sup>th</sup> Meridian
  - Section 1
  - Section 2
  - Southeast Quarter Section 3
- (b) Township 50, Range 24, West of the 4<sup>th</sup> Meridian
  - Section 33
  - Section 28
  - North half of Section 22
  - North half of Section 23
- (c) Roads
  - All the Government Road Allowances within the Proposed New Town Boundary.
  - All that portion of Range Road 242 adjacent to the west boundary of Northwest quarter of Section 2, Township 51, Range 24, West of the 4<sup>th</sup> Meridian.
- (d) Schedule "A" to this Notice is a an amended map of the proposed annexation area.

**4. Reasons for the Proposed Annexation**

(a) Letter to Affected Landowners

The Town proposes to issue a letter to affected Leduc County landowners advising them of the Amended Notice.

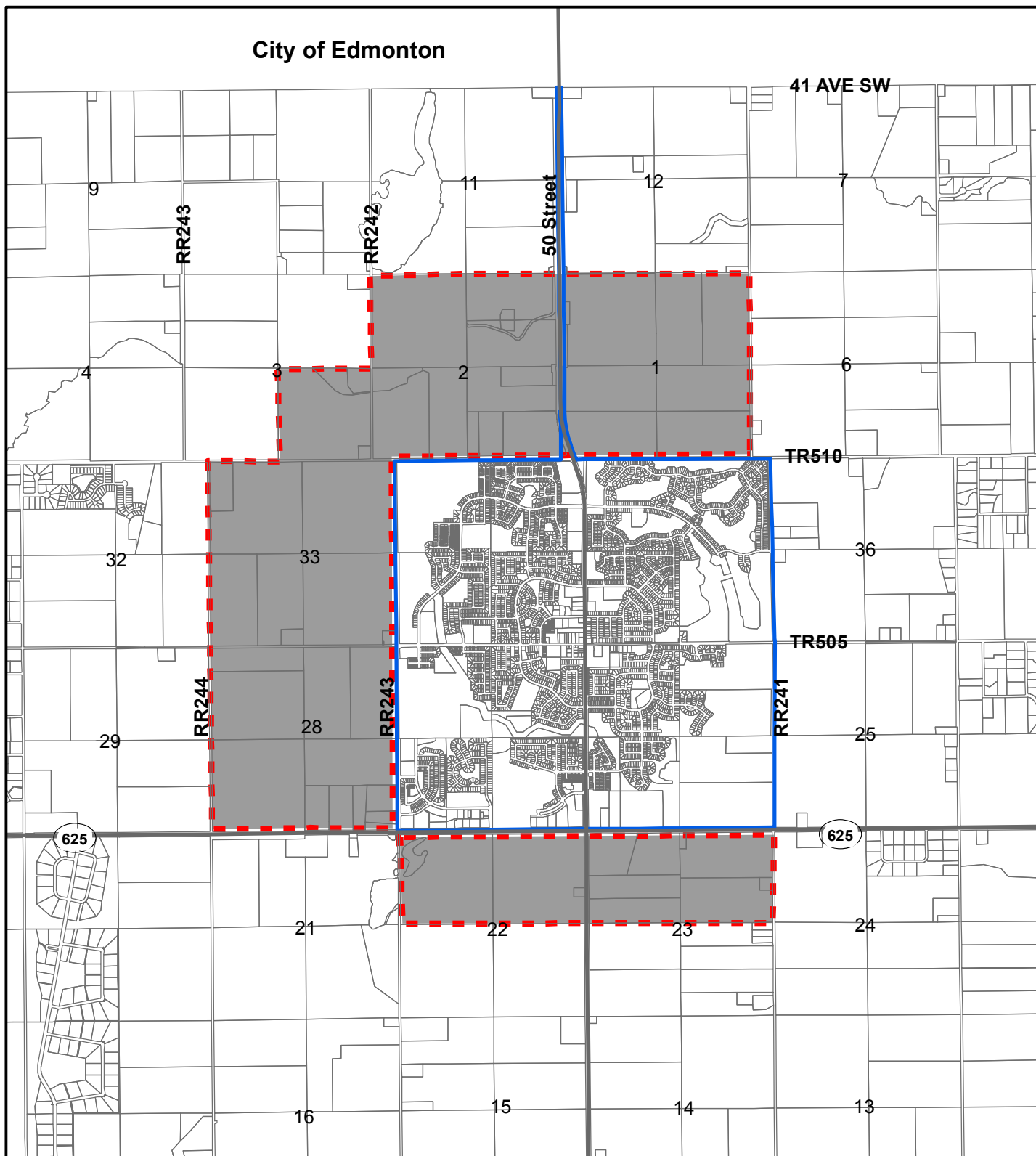
(b) Website
