Access to Private Property Through/Over City Managed Land

SECTION 1 - PROCEDURE FOR AUTHORIZING ACCESS	
This is the procedure for authorizing Non-City Vehicles and Equipment on City Managed Land:	
<ol style="list-style-type: none">1. Complete Access Request Form and submit to Parks and Facilities, see box above.2. Allow 7 working days for pre-inspection and authorization process.3. Access Requester should be present at time of pre-inspection and post-inspection.4. When the Access Request Form has been approved it will serve as permission to proceed with conditions as noted. This documentation is to be available on-site and presented when requested by Municipal Enforcement or by other City of Beaumont Departments.5. As soon as the project is complete, Access Requester is to contact City Representative noted on pre-inspection report (see reverse). Failure or delay to do so may result in repair costs to Access Requester.6. The Access Requester will be held responsible for any damage incurred as noted on the post-inspection report.7. The project may be stopped temporarily due to wet weather.
